#### 13.188 Declarations of Interest

Councillor P Conway declared an interest in any planning matters.

#### The Chairman imposed standing orders

#### 13.189 Presentation of Solicitor (Broomside Land)

Nigel Cooper from Cooper Stott Solicitors reported that Mr Nelson would

- Withdraw his objection on the basis that there is a transfer to him of a portion of land sufficient to park a car (preferred width of 10 feet)
- The transfer would be subject to a covenant: not to develop the land
- Mr Nelson is prepared to pay the sum of £2000.00 as consideration to the Council
- Mr Nelson would bear the legal costs of conveyancing the land

Mr Nelson would fence off the agreed measurements strip of land at his cost

Solicitor advised that the offer should be **accepted** as Mr Nelson is confident that there is sufficient evidence to show that Parish Council has not had exclusive possession for the requisite period.

Councillor J. Knight raised concerns, why information wasn't handed out prior to the Parish Council Meeting.

Chairman D.J. Southwell explained that the information was too sensitive.

#### The Chair Suspended Standing orders

A member of the Public raised the concern that Belmont Parish Council had consistently maintained the land from 1994 to the present time and anything prior to that was irrelevant.

Councillor Conway raised concerns of ownership exclusivity and solicitors judgement. Nigel Cooper explained that the Parish Council would have had to take exclusive ownership of the land with fencing complete, he said in his opinion that the party that loses would pay the cost which would not be financially viable to the Parish Council.

Councillor B. Howarth queried the suggestion of imposing a covenant before the Parish Council receives the land granting title possession to the land.

The Parish Clerk as the Responsible Financial Officer advised the council that it would be a substantial cost to Belmont Parish Council as Mr Nelson was **not** going to change his mind and advised that members should consider carefully whether or not to accept the offer based on the advice given by the solicitor Mr N. Cooper.

**Proposed:** by Vice-Chair G. Robinson-Lundy the council to take solicitors advice and not risk losing the case.

seconded by Councillor D Waggott.

#### 13.191 <u>Miscellaneous Reports</u>

PC Johnson attended the meeting at 6.15 p.m.

#### (a) Police

- (1) Thefts- An arrest was made in January, the person in question has been remanded in custody awaiting trial subsequently there has been no reports of vehicles been broken into in the parish area.
- (2) Burglary There was one reported burglary in Beechdale Road no suspects at this time.
- (3) Criminal Damage There was one report of criminal damage to door in Cheveley Park Shops. There were no suspects at this time
- (4) Anti-Social Behaviour There were twelve reports of anit-social behaviour in Belmont/Carrville, two in Gilesgate Moor youths causing a nuisance.

Councillor S Inglis raised a concern over house disturbance by students in the early hours.in Gilesgate Moor.

Councillor S Inglis raised the concern of a resident at a recent PACT meeting in Carrville and the resident resides in Gilesgate Moor.

The Chair thanked the police.

#### **(b)** Community Warden

Concerns were raised over youths and anti-social behaviour in the evening hours, PCSO presence would be enforced to help combat this issue.

Dog fouling – Concerns were raised over dog fouling in the area, Wardens were aware of this issue and were targeting suspect areas i.e. early morning and early evening (popular dog walking times). Signs on lampposts with the fixed penalty warning are currently in operation. Councillor Knight enquired how does the process move from the owners not picking it up .Wardens to approach offenders and give them a fixed penalty which has to be paid in fourteen days or offenders will be taken to court. Wardens have investigated twenty one reports of dog fouling and issued one fixed penalty notice for dog fouling, also removed ten stray dogs.

Councillor Howarth raised the concern if you have no witness statement is their manpower for monitoring. Wardens can monitor but not over a long period of time as they cover such a large area. Councillor Mavin was pleased fixed penalties were being given out but were there any given within the parish? The Warden replied he couldn't comment how many but would speak to his line division on the matter.

Littering – There have been three reports of littering and twenty one fixed penalty notices for littering this month.

Fly-tipping – There have been one hundred and thirty two incidents of fly-tipping this month, fifty nine investigations into these incidents in order to find any evidence to link the the fly tipping to those who dumped it.

Untidy yards and gardens – There were no advisory letters or litter clearing notices this month.

Counciller Mavin raised the concern of graffitti on Lamorna Bridge the Warden said here were currently four Wardens involved with fly tipping investigations Mobile phone number 07795497796.

Concerns were raised from a member of the public in relation to students causing a disturbance in the early hours of the morning.

At a recent PACT meeting a resident had raised concerns of abuse from local school children in the area and in the local supermarket
