#### 15.113 Wantage Road area feedback.

Councillor P Conway gave a verbal report to members.

Councillor P.Conway reported on the issue of traffic problems on Wantage Road as raised by some local residents. Following two meetings during the summer, a further one had been arranged by county councillors on 12<sup>th</sup> October 2015 to consider various options presented by highways officers.100 % invitations had been delivered to local residents who could be affected. Between 50 and 60 residents attended the meeting and county councillors had received 20-25 representations from people unable to attend.

Following a wide ranging discussion the meeting concluded

- (a) No option would solve the problems as perceived by some residents
- **(b)** Therefore no further work should proceed on options.
- (c) Traffic movement in the east of the city was a major challenge and the County Durham Plan should examine this matter, taking into account the need for traffic management on the A690 at Rainton, the need for junction improvements on the motorway and improved circulatory traffic management in the Belmont, Carrville and Gilesgate Moor area
- (d) The efficiency of road bumps on Wantage Road should be investigated and representations to Lees coaches made about their use of the road.
