# 15.156 To Consider and Make Comment on Planning Matters\*

Obtained from Durham County Council Planning Department for January 2016. Planning Application DM/16/0018/FPA – New Ferens Park.Diagnostic Treatment Centre. Planning Application DM/16/00026/FPA – Change of use from B2 to a mixed class use retail A1 and restaurant/café A3 at 107a High Street, Carrville.

A frank and open discussion took place regarding the above planning applications.

Councillor Howarth commented on current planning applications with reference to DCC Planning List for January 2016 and Delegated Outcomes for January 2016 drawing attention to related Parish Council action.

Planning Report for Jan/Feb 2016 then presented – summarised as follows:

Application DM/15/00355/VOC: Variation of condition 2 of approval CE/13/00849/FPA Renny's Court, Gilesgate Moor for Studio US Ltd.

Pending decision

Application DM/15/02276/FPA: Angerstein Court, Broomside Lane, Carrville. Conversion of an Existing Cycle and Maintenance Store into Studio Apartment.

In Sept 2015 the Planning Committee held a site visit and a letter of objection was sent with request for referral to DCC Committee - ratified at Full Council with agreement that PC rep should speak. A subsequent plan has been submitted showing proposed relocation of the secure bike store but the Parish Council agreed to uphold their opposition to the application.

Pending decision

Application DM/15/03186/FPA: A690 Specialist Cars Ltd. Belmont Bridge Carrville, Durham. Extension of garage to form workshop.

The Parish Council's main objection was to the loss of onsite parking. A subsequent application compensates this loss by encompassing grass verge, subject to legal decision. A boundary wall has since been proposed to separate premises from A690 and councillors agreed there are no further planning reasons to oppose the application.

Pending decision.

Application DM/14/02912/OUT: 120 dwellings off Mill Lane, Sherburn Village. Letter of objection sent due to concern about additional strain on shared medical facilities.

Pending APPEAL AGAINST REFUSAL. No further comment to be sent from Belmont PC

Application DM/16/00018/FPA: Land South of New Ferens Park, Belmont Industrial Estate. New diagnostics and treatment centre.

Agreed not to oppose application but emphasise need for landscaping and ecological safeguarding as possible. The protection of trees with Tree Preservation Orders to be stressed.

Application DM/16/00026/FPA: 107a High Street Carrville. Change of use from B2 to a mixed class use retail A1 and restaurant/café A3.

PC requested application should go to DCC Planning Committee. Agreed to object to application on grounds of lack of parking and its effect on resident amenity and other local businesses.
