Tim Boyd General Manager of Ramside Hall Estates gave a report regarding the community use of 106 monies following on from his previous meeting with Councillors J. Knight and E. Mavin. Additional people attending the meeting were Councillors T. Charlton, K.Corrigan and resident K.Holroyd. It was agreed to offer golfing lessons, community meetings, toddler groups swimming within the parish area and other parishes.

A full and comprehensive report was given by the police.

(b) <u>Community Warden</u>

A full and comprehensive report was given by the Community Warden. With regards to dog fouling in the area, it is difficult to catch an offender, although there are frequent patrols throughout the day, wardens need to know specific times, location, type of dog, owner details in order for them to send someone to take action i.e. fines.

It was reported that there were now new signs for dog fouling, which light up

on an evening, although expensive the Warden was going to approach Durham County Council for financial assistance.

A resident raised concerns of reduced street lighting in Broome Road resulting in poor driving conditions. The resident gave her contact details to County Councillor P. Conway who would look into the matter.

A resident raised concerns regarding the junction at Barclays Bank, Carrville saying it was difficult getting out. It was agreed for County Councillors to meet with Highways Officers regarding the matter.

A resident raised concerns of street lighting in Ashdown Avenue, it was reported that the matter was being dealt with.

The Chairman Councillor D.J. Southwell thanked Belinda for all her hard work. The Vice-Chairman Councillor R. Murphy thanked the Community Warden for organizing the litter pick on Renny's Lane.

A resident raised concerns regarding anti-social behaviour near Belgravia House with regards to anti-social behaviour concerning drug abuse and illegal selling, the matter was reported to the Police by the resident but there has been no further update

A resident raised concerns regarding youngsters speeding on quad bikes along a popular country path regularly used by ramblers and dog walkers along Rennys Lane

A resident raised concerns regarding the closure of Durham Light Infantry Museum. Durham County Councillor P. Conway reported that the building was closing at the end of the month, A special exhibition will be held on Palace Green, larger items will be displayed at Spennymoor and archives will be held in Durham Records.Office.

A resident raised concerns regarding the high volume of litter at the spaghetti junction leading into the A692, dog fouling in the area, anti-social behaviour in the carpark near the woods and also a damaged bus shelter.

A concern was raised regarding Cheveley Park Primary School trees which overhang the back lane of Broomside Lane. Councillor Howarth reported that work has been done on the lower limbs of the trees by Durham County Council, but asked that enquiry to be made, via Durham County Council Tree Section, on whether more work is necessary.

Councillor E. Mavin raised concerns about rear of Broomside Lane resurfacing from houses starting at 88 down over to the last house on Broomside Lane just before the railway bridge.

A concern was raised over speeding from Broomside Lane to Pittington Road, historically there used to be road markings there to slow traffic down coming onto Broomside Lane from Pittington.

Carrville

Councillor T. Charlton reported on the amount of cigarette ends outside Ballantynes Health Club.

Gilesgate Moor

Concerns were raised over refuse bins and recycling boxes being strewn across pavements after emptying on collection day. Durham County Councillor said it was the responsibility of the residents to put the bins back onto their property after bins had been emptied.

Councillor Inglis raised concerns of a footpath becoming obstructed whilst repairs were made to overhead telephone cables by Contractors. County Councillor P. Conway reported that complaints had been logged regarding this matter and action had been taken.
